





This route combines study with real hands-on work, first gaining an introductory qualification before studying to qualify as a chartered accountant. You will be fully qualified within four years, so this is a fantastic opportunity if you want to progress quickly, earning while you learn and avoiding the costs of university life.

10. Application process / Who we look for

01

Online application

Browse our vacancies to choose a suitable location and opportunity that fits your career goals and complete your online application. Do your research and tailor your application to ensure you demonstrate the skills required to your full potential.



02

Online aptitude assessment

After completing your application, you will be asked to do our online aptitude assessments. This includes a numerical and verbal reasoning test. Afterwards you will receive a report outlining your strengths and areas to focus on.



03

First interview

If you are successful in both our online application and aptitude assessments, you will be invited to a telephone interview. If you are unsuccessful at this stage, you'll be offered a feedback session to help with your development and support your next steps.



04

Assessment centre

If successful in your telephone interview, you will be invited to partake in one of our assessment centres. These are currently run virtually. Prior to the day, we'll offer you a coaching call to help you prepare and we'll connect you with a recent joiner for advice and guidance.
